Instructions to Author:

- Authors are requested to submit the paper abstract and full length manuscript (in .pdf and in .docx formats) by email to the below mentioned email ids.
- Abstract limited to 200 words may be submitted once accepted, full length paper may be submitted.
- Names and designations with affiliations of three suggested reviewers shall be provided at the time of submission of full length paper separately.
- Submission of a paper implies that it has not been published previously, that it is not under consideration for the publication elsewhere, and that if accepted it will not be published elsewhere.
- Author agreement/declaration/Undertaking in the prescribed format shall be mandatorily submitted before acceptance of paper.
- All manuscripts must be brief and concise. International units must be followed and obsolete units must be avoided.
- Authors are requested to submit their manuscripts in accordance with the format specified in the Paper template given below.
- Short biographies of ALL authors shall be provided as part of the paper as mentioned in the paper template.
- Please adhere to the deadlines provided and visit CPRI website for latest information and updates pertaining to this conference.
- All photographs used in the paper must also be sent separately as a high resolution image in .jpeg / .png format.
