Sub: Registration Fees for Training/ Workshops/Seminars/Conferences/webinars for the year 2021-22.

In supersession of Circular No.CPRI/Adm/3(6)/2021 dated 16.04.2021, as approved by the Competent Authority, the concessional rates of registration fees for Training/Workshops/Seminars/Conferences/Webinars for the year 2021-22 to be offered to the participants from Power Utilities/Educational Institutions/Government bodies etc. are indicated as follows :

- a) The registration fee chargeable for **Non-residential programmes** and the concessional rates to be offered to the participants from Power Utilities/Educational Institutions/Government bodies etc. are indicated as follows: **For the exclusive programmes undertaken for any customers such as Government undertakings/Public/Private etc., a minimum number of 10 participants per batch will be charged. Beyond 10 persons pro-rata charges will be applicable.**


